Blockbase is a product of the brand agap2IT. It is a platform that provides database management, operation, and usage services similar to a scalable cloud service, but where these will persist over a Blockchain system. The system is designed to work only with encrypted data, never getting to know the original data. The junction between cryptography and Blockchain technology allows creating systems that reveal excellent security qualities, complying with the CIA triad (Confidentiality, Integrity, Availability).

All personal data provided will be treated with the guarantee of security and confidentiality required by the legal framework with regard to the protection of personal data.

Guidelines

This policy seeks to define how the personal data of users of the BlockBase website are treated.

Similarly, agap2IT, as the managing body of the BlockBase website, is required to comply with this policy in accordance with the obligations of Regulation 2016/679/EU of the European Parliament and of the Council of 27 April 2016, on the protection of individuals regarding the processing of personal data and on the free movement of such data (hereinafter referred to as "the Regulation").

We guarantee confidentiality in the processing of your data

Personal data are considered confidential and as such are covered by legal confidentiality obligations. The processing is supervised by the data protection officer who will ensure that only duly authorized persons can process certain data.

PERSONAL DATA

How consent is given

The consent of the individual must be expressed freely, voluntarily, and explicitly and shall be obtained through a record of acceptance.

How we collected the data information

Website user data: when you visit our website, whenever you accept the use of cookies, in accordance with the cookie settings of your browser, and where appropriate and in accordance with the provisions of the laws, your data may be collected automatically or through you. What data we need to collect

The personal data collected shall be such as are necessary for the purposes for which they are intended and which are determined, explicit and legitimate.

Personal data shall be processed lawfully, fairly, and transparently in relation to the data subject.

The data subject shall be informed about the purpose of the processing rigorously and in accordance with the a priori procedures established.

For the fulfilment of the business activity, the responsible office needs to collect and process the following data:

What is the purpose of the data processing

Website user data: They are used for:

- i) Improving the user experience of our website;
- ii) Presentation of content that we think is of interest to you.

How long the data will be kept

Personal data will be stored, without prejudice to legal provisions or regulations to the contrary, for the period necessary for the purposes for which they are intended and for which they are processed.

Violation of Personal data

It is considered a violation of personal data any act that calls into question the security of the data, in an accidental or unlawful manner, and causes the unauthorized destruction, loss, alteration, disclosure or access to personal data transmitted, stored or subject to any other type of treatment.

BlockBase has been working to maintain and preserve personal data with a high level of security. However, small deviations from the forecast can always occur. If any of our customers or users detect or suspect a possible data breach, they should immediately send an email to gdpr@agap2.pt, indicating what happened, as well as identifying the data that may be involved. In this way, the responsible department will be able to act quickly and properly, in accordance with the standards established in the Regulation.

YOUR RIGHT

Right of the data subject

According to the actual legislation and depending on the limitations applicable to the specific case, the data subject has the right to information, access, rectification, erasure/forgetfulness, restriction of processing, opposition and data portability.

COOKIES

What are the cookies?

Cookies are small text files, which are stored on your computer or mobile device via your internet browser (browser). By browsing, they record your preferences and allow the website to identify your device the next time you visit.

At any time, you can decide to be notified of the receipt of cookies, consult, or change the type of cookies, as well as block their entry into your system, through the settings of your internet browser.

Why are they used?

Cookies are an essential part of the operation of our website and to facilitate your navigation on the Platform, the main purpose of which is to improve your search experience. For example, they are used to help determine the usefulness, interest and number of websites uses, enable faster and more efficient browsing, and eliminate the need to repeatedly enter the same information.

The information collected by Cookies also allows us to improve the website through estimates and usage patterns, and to allow its suitability to the individual interests of users.

As described below, the website uses technical or strictly necessary cookies, performance cookies, functionality cookies and advertising cookies. Each of these cookies may be installed by the agap2IT websites (own cookies) or by websites external to agap2IT (third party cookies) and may be removed as soon as the user leaves the website (session cookies) or remain on the terminal device after the user leaves the website (persistent cookies).

The cookies currently used by the website are as follows:

Technical or strictly necessary cookies

Technical or strictly necessary cookies are cookies installed for the purpose of allowing navigation on the website, allowing a correct user experience, namely the security of the website or the management of consents. For this reason, these cookies do not require your consent.
